PacifiCorp the Company

- ▶ 1.7 million customers across 6 states
 - **▶** 53% (890,000) in the Southwest Region
- Fully integrated electric utility
- ▶ Net generation capacity 9,140 MW
- Three business units
 - Pacific Power
 - >> Rocky Mountain Power
 - ▶ PacifiCorp Energy
- Acquired by MidAmerican Energy Holdings Company in March 2006





Rocky Mountain Power's Southwest Region Residential Programs

- ▶ Cool Keeper CAC dispatchable load control/management
- ► Cool Cash CAC efficiency (electric and evaporative)
- ▶ EnergyStar New Homes New residential construction
- ▶ Home Energy Savers Appliances, lighting, HVAC, shell measures, etc.
- ▶ See ya later refrigerator refrigerator/freezer recycling
- ▶ Low Income Weatherization Community Action Agency delivery
- Online and Mail-in home analysis/audits
- ▶ PowerForward Voluntary curtailment, residential/business
- ▶ Summer inverted rates residential customers
- ▶ Time of use rates all customer classes
- ▶ "Do the bright thing" demand-side messaging and education



Rocky Mountain Power's Southwest Region Business Programs

- ▶ Energy FinAnswer comprehensive projects, engineering svcs
- ▶ FinAnswer Express speed for single measure projects
- ▶ Self-Direction/large customer program − 80% project costs
- ▶ Retro-commissioning program building tune ups, light repair
- ▶ Firm curtailment contracts special contract customers
- ▶ PowerForward Voluntary curtailment, residential/business
- ▶ Energy Exchange web based bid program
- Time of use rates

Wyoming Progress?

- ▶ DSM application was file in December, 2006
- ▶ Hearings in April, 2007
- Deliberations in June (cancelled), July (cancelled) and August, 2007
- Application suspended in August, 2007
- December, 2006 Proposal:
 - ▶ 3 year pilot, capped at 1% of retail revenues per year (\$1.5M/yr to ?)
 - >> Optional participations for large commercial and industrial
 - ▶ 4 programs initially
 - ✓ Low Income Weatherization
 - ✓ Home Energy Savers with builders option
 - ✓ FinAnswer Express
 - ✓ Self-Direction/large customer
 - ▶ Introduction of a "Customer Efficiency Service" charge recovery
- Will be re-filing with amendments in December, 2007
- New proposal? that's a secret

Energy Efficiency


- ▶ All Utah, no Wyoming in 2006, 2007 or forecasted for 2008. Wyoming coming on in 2009. Load control/scheduled firm
- Utah's Cool Keeper = 88MW 2006, 93 MW 2007, 100 MW 2008
- ▶ Utah irrigation = 3 MW in 2007 and 10 MW 2008
 - >> FYI, Idaho irrigation program expected to reach 100-150 MW in 2008 (80 MW in 2007)
- Curtailment agreements special contract customers
- PowerForward results (not in above) = 15 to 220MW
- ▶ Energy Exchange results (not in above) = 0 to 8 MW, 7 events in 2007 and 320 MWH

"Exciting and New" in 2007

- ▶ Extended Idaho scheduled irrigation load management into Utah
- Piloted a dispatchable irrigation program
 - ▶ Idaho program reached 80 MW in 2007
 - ✓ Day ahead scheduling, 65 hours max per season
- Completed a system-wide potential study, June 2007
 - Minimum of 409 aMW identified as achievable in SW Region by 2027
 - >> Company intends to aggressively pursue in condensed timeframe
- Utah PV buy-down program September, 2007. \$2/watt, \$300k/yr
- ▶ Co-sponsored 2006 IECC codes training program in Utah
- Utah Governor Huntsman's energy action plan released
- ▶ Took our first run at introducing DSM to Wyoming



Looking Ahead to 2008

- Get moving in Wyoming
- Incorporation of potential study information into IRP process
- Utah cost-effectiveness re-evaluation effort
- ▶ DSM RFP (Plan is to kick out yet this year, new projects 2008)
- Coordination with Utah energy policy action plan
- Possible expansion of dispatchable irrigation load control to Utah
- ▶ Thermal energy storage pilot project (183 kw project in SLC)
- Add measures to FinAnswer Express (plug loads, 80+, new lighting technologies, others as identified)
- Revisit business program incentive levels, looking for more lift
- Accelerate the pursuit of res & com lighting (what's everyone else doing)
- Other interests...
