2019 LEGISLATIVE ACTIVITY SUMMARY

In the Southwest region, the state legislatures in Colorado, Nevada, Utah, and New Mexico met during the first and second quarters of 2019. The Southwest Energy Efficiency Project (SWEEP) actively engaged in each session to advance energy efficiency and clean transportation through sound and effective legislation. These efforts included researching and writing bill language, building coalitions, and testifying at committee hearings to advocate for the passage of energy efficiency and clean transportation legislation.

Details on SWEEP's 2019 legislative efforts, along with information on the outcome of energy efficiency bills in the four states, are described below.

HB19-1157 - Modify Specific Ownership Tax Rates

Sponsor: Rep. Larry Liston

Defeated - SWEEP opposed this bill.

Bill Summary: On and after July 1, 2020, the bill modifies the rates of specific ownership tax imposed on motor vehicles, commercial trailers, and special mobile machinery that is less than 25 years old, increasing the total amount of specific ownership tax revenue collected. Additional specific ownership tax revenue generated by the specific ownership tax rate modifications is transferred to the highway users tax fund (HUTF) for allocation to the state, counties, and municipalities in accordance with the existing "second stream" statutory formula for the allocation of HUTF money. The state, counties, and municipalities may expend the revenue only for construction, reconstruction, repairs, improvement, planning, supervision, and maintenance of state highways, county roads, and municipal streets, including the acquisition of rights-of-way and access rights.

Bill Activity: HB19-1157 went to the House Committee on Transportation & Local Government and was postponed indefinitely.

HB19-1159 - Modify Innovative Motor Vehicle Income Tax Credits

Sponsors: Rep. Sonya Jaquez Lewis | Rep. Matt Gray | Sen. Jessie Danielson

Passed - SWEEP supported this bill.

Bill Summary: Concerning modifications to the income tax credits for innovative motor vehicles. The bill modifies the amounts of and extends the number of available years of the existing income tax credits for the purchase or lease of an electric motor vehicle, a plug-in hybrid electric motor vehicle, and an original equipment manufacturer electric truck and plug-in hybrid electric truck.

Bill Activity: HB19-1159 passed in the House and the Senate and was signed into law by Governor Polis.

HB19-1198 - Electric Vehicle Grant Fund

Sponsors: Rep. Alex Valdez | Rep. Donald Valdez | Sen. Jeff Bridges | Sen. Kevin Priola

Passed - SWEEP supported this bill.

Bill Summary: Concerning the powers and duties of the electric vehicle grant fund, this bill modifies the statute governing the electric vehicle grant fund (fund) as follows: Allows the fund to be used to administer grants for the installation of charging stations for electric vehicles; allows the fund to prioritize the grants it will provide based on criteria defined by the Colorado energy office; allows the fund to be used to fully fund the installation of charging stations and offset station operating costs; and requires the money in the fund to be continuously appropriated to the Colorado energy office.

Bill Activity: HB19-1198 passed in the House and the Senate and was signed into law by Governor Polis.

HB19-1199 - Colorado Clean Pass Act

Sponsors: Rep. Alex Valdez | Sen. Brittany Pettersen | Sen. Faith Winter

Defeated- SWEEP supported this bill.

Bill Summary: Concerning the conditions under which operation of a plug-in electric motor vehicle on an express lane without regard to the number of persons in the vehicle and without payment of a toll or with payment of a reduced toll is allowed.

Bill Activity: HB19-1199 was introduced in the House where it passed in the Energy & Environment and Appropriations Committees. It was then referred to the House Committee on Finance where it was postponed indefinitely.



<u>HB19-1231 - New Appliance Energy And Water Efficiency Standards</u>

Sponsors: Rep. M. Froelich | Rep. C. Kipp | Sen. Pete Lee | Sen. Kevin Priola

Passed - SWEEP supported this bill.

Bill Summary: Concerning efficiency standards for equipment sold in Colorado, and, in connection therewith, requiring certain appliances, plumbing fixtures, and other products sold for residential or commercial use to meet energy efficiency and water efficiency standards. The bill updates and adopts standards for water efficiency and energy efficiency that apply to a list of consumer and commercial appliances and other products. The standards are based on state standards, federal Energy Star and WaterSense specifications, and industry standards in most cases or, where a standard is not incorporated by reference, the standard is specified by statute.

Bill Activity: HB19-1231 passed in the House and the Senate and was signed into law by Governor Polis.

<u>HB19-1258 - Allocate Voter-approved Revenue For Education & Transportation</u>

Sponsors: Rep. KC Becker | Rep. Julie McCluskie | Sen. Lois Court | Sen. Kevin Priola

Passed - SWEEP supported this bill.

Bill Summary: Concerning the allocation of money that the state keeps and spends as a result of a voter-approved revenue change at the 2019 statewide election. The bill was contingent on voters approving a related referred measure to annually retain and spend state revenues in excess of the constitutional spending limit. This measure passed meaning that in years when the state retains and spends revenue under the authority of the measure there will be additional revenue in the general fund exempt account.

Bill Activity: HB19-1258 passed in the House and the Senate and was signed into law by Governor Polis.

HB19-1260 - Building Energy Codes

Sponsors: Rep. Cathy Kipp | Rep. Alex Valdez | Sen. Faith Winter | Sen. Kevin Priola

Passed - SWEEP supported this bill.

Bill Summary: Concerning an update to the minimum energy code for the construction of buildings. The bill requires local jurisdictions to adopt one of the three most recent versions of the international energy conservation code at a minimum, upon updating any other building code, and encourages local jurisdictions to update the Colorado energy office on any changes to the jurisdictions' building and energy codes.

Bill Activity: HB19-1260 passed in the House and the Senate and was signed into law by Governor Polis.

HB19-1298 - Electric Motor Vehicle Charging Station Parking

Sponsors: Rep. Jovan Melton | Sen. Kevin Priola

Passed - SWEEP supported this bill.

Bill Summary: Concerning the use of electric motor vehicle charging stations for parking a motor vehicle. The bill authorizes the owner of a plug-in electric motor vehicle (electric vehicle) charging station to install a sign that identifies the station.

Bill Activity: HB19-1298 passed in the House and the Senate and was signed into law by Governor Polis.

HB19-1325 - Electric Car Manufacturers May Sell Directly To Consumers

Sponsors: Rep. Chris Hansen | Rep. Hugh McKean | Sen. Kevin Priola | Sen. Jeff Bridges

Defeated - SWEEP supported this bill.

Bill Summary: Concerning increasing consumer access to electric motor vehicles by allowing electric motor vehicle manufacturers to sell their own electric motor vehicles directly to consumers. Current law states that, with certain exceptions, a motor vehicle manufacturer may not own, operate, or control any motor vehicle dealer or used motor vehicle dealer in Colorado. The bill creates a new exception that allows the ownership, operation, or control of a motor vehicle dealer by an electric motor vehicle manufacturer that engages exclusively in the sale of electric motor vehicles of the same line-make as are manufactured by the electric motor vehicle manufacturer.

Bill Activity: HB19-1325 passed in the House after a second reading with amendments and was defeated in the House following reconsideration after the third reading.

SB19-051 - Increase General Fund Funding For Transportation

Sponsors: Sen. Ray Scott | Sen. John Cooke

Defeated - SWEEP opposed this bill.

Bill Summary: Concerning the dedication of additional general fund money to fund transportation needs. Current law, enacted in Senate Bill 18-001, requires the state treasurer to transfer, on July 1, 2019, a total amount of \$150 million from the general fund to fund transportation needs. The bill increases the total amount of the July 1, 2019, transfer to \$340 million so that the amount of the individual transfer to the multimodal transportation options fund is unchanged and the individual transfers to the state highway fund and the highway users tax fund are increased.

Bill Activity: SB19-051 was introduced in the Senate and assigned to the Committee on Transportation & Energy where it was postponed indefinitely.



SB19-053 - California Motor Vehicle Emission Standards

Sponsor: Sen. John Cooke

Defeated - SWEEP opposed this bill.

Bill Summary: Concerning a prohibition on the air quality control commission adopting air quality control standards for motor vehicles that are more stringent than the federal standards. The bill prohibits the air quality control commission from adopting motor vehicle emission standards that are more stringent than federal standards and from adopting the California motor vehicle emission standards and test procedures unless they are the same as the federal standards.

Bill Activity: SB19-053 was introduced in the Senate and assigned to the Committee on Health & Human Services where it was postponed indefinitely.

SB19-077 - Electric Motor Vehicles Public Utility Services

Sponsors: Sen. K. Priola | Sen. A. Williams | Rep. C. Hansen

Passed - SWEEP supported this bill.

Bill Summary: Concerning measures that affect the development of infrastructure used by electric motor vehicles, and, in connection therewith, establishing a process at the Colorado public utilities commission whereby a public utility may undertake implementation of an electric motor vehicle infrastructure program within the area covered by the utility's certificate of public convenience and necessity. Currently, public utilities may provide charging ports or fueling stations for motor vehicles as unregulated services. The bill authorizes public utilities to provide these services as regulated or unregulated services and allows cost recovery. The bill requires a public utility to apply to the public utilities commission (commission) to build facilities to support electric vehicles. Standards are set for approval.

Bill Activity: SB19-077 passed in the House and the Senate and was signed into law by Governor Polis.

SB19-236 - Sunset Public Utilities Commission

Sponsors: Sen. Leroy Garcia | Sen. Stephen Fenberg | Rep. Chris Hansen | Rep. KC Becker

Passed - SWEEP supported this bill.

Bill Summary: This bill includes a requirement that electric utilities and the Colorado PUC use a carbon emissions cost of at least \$46 per ton of CO2 in all resource planning deliberations and decisions, including energy efficiency plan and program evaluations. This policy should result in additional energy efficiency and demand response programs passing cost effectiveness screening. SB19-236 also includes a requirement that wholesale electric cooperatives submit resource plans to the Colorado PUC for review and approval. This policy could lead to expansion



of the energy efficiency and demand response programs implemented by Tri-State Generation and Transmission as well as local rural electric cooperatives in the state.

Bill Activity: SB19-236 passed in the House and the Senate and was signed into law by Governor Polis.

SB19-239 - Address Impacts Of Transportation Changes

Sponsors: Sen. Faith Winter | Sen. Jeff Bridges | Rep. Matt Gray | Rep. Chris Hansen

Passed - SWEEP supported this bill.

Bill Summary: Concerning means of addressing the impacts of technological and business model changes related to commercial vehicles, and, in connection therewith, requiring the department of transportation to convene and consult with a stakeholder group to examine impacts of new transportation technologies and business models, identify means of addressing impacts, and report findings and make recommendations to the general assembly. The bill requires the department of transportation (CDOT) to convene and engage in robust consultation with a stakeholder group comprised of representatives of specified industries, workers, governmental entities, planning organizations, and interest groups that will potentially be affected by the adoption of new and emerging transportation technologies and engage in robust consultation with a stakeholder group comprised of representatives of specified industries, workers, governmental entities, planning organizations, and interest groups that will potentially be affected by the adoption of new and emerging transportation technologies and business models.

Bill Activity: SB19-239 passed in the House and the Senate and was signed into law by Governor Polis.

AB 401 - AN ACT relating to motor vehicle registration; imposing a fee based on vehicle miles traveled upon the renewal of registration of certain light-duty motor vehicles; requiring the Department of Motor Vehicles to calculate and charge such a fee; requiring deposit of certain portions of the fee in the State Highway Fund; requiring the Department of Transportation to provide a report to the Legislature concerning the highways of this State; providing a penalty; and providing other matters properly relating thereto.

Sponsor: Assemblyman Alexander Assefa

Defeated-SWEEP opposed this bill.

Bill Summary: Revises provisions governing the highway funding mechanism, including adopting a fee based on vehicle miles traveled.

Bill Activity: AB 401 was referred to the Committee on Legislative Operations and Elections where no further action was allowed.

AB 483 - AN ACT relating to motor vehicles requiring the Department of Motor Vehicles to conduct a pilot program to gather data from certain motor vehicles in this State; requiring the Department to provide certain reports based on the data gathered; requiring certain owners of motor vehicles to provide to the Department certain information at the time of registration and transfer or renewal of registration of motor vehicles; and providing other matters properly relating thereto.

Sponsor: Assembly Committee on Growth and Infrastructure

Passed - SWEEP supported this bill.

Bill Summary: Revises provisions relating to motor vehicles.

Bill Activity: AB 483 was approved by the Assembly and Senate and was signed into law by Governor Sisolak.

AB 54 - AN ACT relating to energy efficiency; revising provisions relating to the energy efficiency of certain lights sold in this State; repealing obsolete provisions relating to the reduction of grid-based energy purchases for state-owned buildings; and providing other matters properly relating thereto.

Sponsor: Assembly Committee on Growth and Infrastructure

Passed - SWEEP supported this bill.

Bill Summary: The bill puts into place a lighting efficiency standard in Nevada of 45 lumens/watt for general service lamps.



Bill Activity: AB 54 was approved by the Assembly and Senate and was signed into law by Governor Sisolak.

SB 114 - AN ACT relating to vehicles; imposing a surcharge on the sale of electric service to charge the battery of an electric vehicle or a plug-in hybrid electric vehicle; requiring the Department of Motor Vehicles to administer the imposition and collection of the surcharge; and providing other matters properly relating thereto.

Sponsor: Sen. James Settelmeyer

Defeated - SWEEP opposed this bill.

Bill Summary: Revises provisions relating to vehicles, including imposing a surcharge on the sale of electricity to electric and plug-in hybrid vehicles.

Bill Activity: SB 114 was referred to the Committee on Growth and Infrastructure where no further action was allowed.

SB 168 - AN ACT relating to energy; revising provisions governing energy conservation and energy efficiency standards for residences with an on-site renewable energy system; and providing other matters properly relating thereto.

Bill Summary: Revises provisions relating to special license plates.



Bill Activity: SB 181 was approved by the Assembly and Senate and was signed into law by Governor Sisolak.

Bill Activity: SB 330 was referred to the Committee on Growth and Infrastructure where no further action was allowed.

SB 428 - AN ACT relating to parking; making it unlawful to park a vehicle in a parking space designated for electric vehicle charging unless the vehicle is being charged; providing a penalty; and providing other matters properly relating thereto.

Bill Summary: Includes restrictions on vehicle parking in spaces designated for electric vehicles.

Defeated HB 185 - SWEEP supported this bill. Defeated SB 333- SWEEP supported this bill.

Bill Summary: Proposed new sections of the Income Tax Act including: Creating the electric vehicle income tax credit in addition to creating the electric vehicle charging unit income tax credit. New proposed sections of the Motor Vehicle Code include: Requiring an additional registration fee for electric and hybrid vehicles and providing that the additional registration fees be distributed to the state road fund.

Bill Activity: HB 185 was referred to the House Energy & Natural Resources Committee and the House Taxation & Revenue Committee and was postponed indefinitely.

Passed - SWEEP supported this bill.

Bill Summary: Requires electric distribution utilities and electric distribution cooperatives to allow nonresidential customers to see their energy usage data in 15 minute intervals through an online portal.

Bill Activity: HB 307 passed in the House and Senate and was signed into law by Governor Herbert.
